## GENERAL CONDITIONS FOR RENTING GREEK TRADITIONAL CLOTHES AND ACCESSORIES

### Article 1: Recitals

1. vzw KAPA is renting costumes and accessories as described in the renting agreement and for an agreed upon duration. The renter accepts the good condition of the rented items. By signing the renting agreement the renter accepts the terms and conditions for delivery and payment. At the time of signing the agreement the renter will be asked to provide a legitimating or identity card.
2. Prior to signing the renting agreement vzw KAPA provides the terms and conditions for payment and delivery to the renter or refers to the renting conditions which can be found on the website [www.dansgroepkalitsa.be](http://www.dansgroepkalitsa.be).

### Article 2: Request for renting

1. Any request for renting needs to be made at least one week in advance.

### Article 3: Renting cost

1. The renting agreement is signed for a given period and against a cost as mentioned in the renting agreement or agreed otherwise in writing
2. The complete rent including the guaranty has to be paid in advance by bank transfer
3. For any costumes and or accessories a guaranty fee needs to be paid. This amounts to 100 Euro per costume with a minimum of 500 Euro.
4. The renting cost for one (1) week amounts to 15 Euro per costume including accessories and will be included in the renting agreement. For renting periods longer than one week an additional rent will be charged at half of the normal rent for every additional week started.

#### Article 4: Collecting

1. Costumes and accessories can be collected from the vzw KAPA storage location.
2. Date and time for collecting and return will be agreed upon and included in the rental agreement.
3. Collecting by the renter takes place during the week before the actual use. Any deviation, if needed, is subject to a common agreement.
4. At time of collecting all items will be checked and counted. All items will be specified as part of the rental agreement including the rental cost, replacement value and guaranty fee. The rental agreement will be established and signed in two copies a copy of which is received by each party. By signing the rental agreement the renter confirms that the collected items are as stated in the agreement and in good and undamaged condition. Any claims after usage cannot be accepted anymore.

#### Article 5: Property

1. Costumes and accessories are the property of vzw KAPA. It is not allowed for the renter to make any changes to the items rented.
2. It is not allowed for the renter to rent out the items to any other third party.

#### Article 6: Usage

1. The renter will take proper care of the rented items and only use them for what they are destined. It concerns traditional clothing for which we expect the renter to treat them with respect.
2. It is not allowed for the renter to perform any cleaning operations as it may cause not repairable damage.
3. It is mandatory for a T-shirt to be worn underneath costumes
4. It is not allowed to wear costumes in bad weather conditions such as rain or snow.
5. After each use the costumes should be put on their respective hangers and allow them to dry. Never put wet clothes in protection covers, suitcases or boxes

#### Article 7: Liabilities

1. From the time of collection and for the entire duration of the rent, the renter is fully liable for any loss or damage of the rented items.

2. In case of damage, loss or theft the renting company will charge the renter for the appropriate costs for repair, cleaning or replacement costs. In case of loss or theft the replacement value as mentioned in the attachment to the rental contract will be charged. In case of damage only the repair costs will be charged
3. In case of damage or loss the guaranty fee will only be reimbursed after the repair or replacements costs are known.

#### Article 8: Return

1. The renter is obliged to return the rented items within the given time frame and at the agreed date and time as mentioned in the rental agreement.
2. The renter informs vzw KAPA immediately when the items cannot be returned at the agreed upon date and time
3. If the renter fails to inform vzw KAPA timely about a change in return date or time additional costs will be charged equal to one additional week of rent.
4. All items need to be returned in their original condition and protection. This means that the correct clothes need to be put on the correct hangers, accessories in the provided bags, etc. In case of failure the guaranty fee will be paid back only after deducting the costs to remedy the situation.
5. At time of returning the items everything will be counted and inspected. The guaranty fee will be reimbursed after eventual deduction for cost of damaged or missing items.

#### Article 10: Applicable jurisdiction

1. Except as otherwise agreed, the Belgian civil law on rental agreements will be applicable
